## 1. Welcome by the Chair

The meeting received a welcome from the Chair.

#### 2. Minutes of the last meeting

#### 4. Survey results July/August 2025

The meeting received the summer survey results with the following headlines:

- i) The passenger numbers compared with the same summer days of 2024 were down around 20%. Welsh Government confirmed that it is a similar picture over the whole rail network. The May survey figures showed trains overcrowded to the same levels as 2024.
- ii) The reasons for the reduction in travel were possibly due to reliability and cancellations.
- iii) The survey is issued separately from these minutes.

The next surveys will be:

- a) Holyhead connections with ferry services.
- b) May 2026.

The survey report for May and August will now be approved by the main Association meeting and then issued formally.

#### 5. Top 10 rail priorities

TFW have asked for the group to come up with their 10 top priorities. These are attached divided into two parts – Cambrian and North Coast lines.

### 6. Reports from rail companies

#### 6.1Transport for Wales

James from Transport for Wales gave a presentation on current information with regard to the Cambrian Lines.







#### The main points were as follows:

- a) Slides issued with these minutes showing most of the information
- b) There was a period in early/mid-August when train services were not as good as they should have been, the situation has improved since that time.
- c) The new depot arrangements (for pumping out etc) at Pwhelli are still awaited some 12 months on.
- d) The white lining to aid passengers with regards to the trains which come into the platform and leave in the same direction as they came in is still awaited. It was suggested that information on destinations could be on the side of the trains.
- e) The Shrewsbury lifts are still out of order. These are to be restored in the next two weeks.
- f) The meeting expressed concern that after 2033 (when the train leases end) the 197 class will still be retained on long distance services. The group has for some time been against the 197 class for long journeys.
- g) The 197 class units are to replace the 158 units either later in 2026 or early 2027.
- h) There is a plan to increase the number of 197 units fitted with ERTMS from 21 to 24 units.
- i) There are no plans at present to link platform 3 better to the other platforms.
- j) There is to be new rail partnership for the Newport to Gobowen section working alongside the Cambrian Lines partnership.
- k) The idea of a rail line (re-instated) from Bangor to Porthmadog was considered an important proposal.

The slides from this presentation are circulated with these minutes. It was noted that there were reports earlier in the day that TFW was the worst rail performing company in the UK.

A meeting with Colin Lea is being arranged regarding the hourly train services and the effect of the Holyhead path from Birmingham-Shrewsbury service. A resolution to issues identified is needed to be agreed.

#### 6.2Network Rail

#### 7. Freight on the Cambrian

To discuss freight services on the Cambrian Lines.







#### 8. Caersws - car parking

The meeting considered an update on a possible solution to the car parking issues at Caersws Station. The Community Council may have secured some land. Welshpool received funding from Welsh Government in 2015 to extend their car paring.

The meeting **AGREED** to support the extra provision of car parking at this location and to help lobby the Welsh Government and TFW for funding.

#### 9. Buses

A short report on the Powys bus changes was given. It has not been introduced well but it is hoped it will settle down very soon.

#### 10.Liaison Committees

**10.1** A rationalisation of user groups directly reporting to TFW etc is taking place. The route for communication on the Cambrian Line will be via this committee. This committee will be expanding membership to make it more inclusive.

#### 10.2 Remit of this committee

The members would be seeking to gain the following out of the user group:

- a) Up to date information from TFW and Network Rail not only at meeting but in between as well via the secretary for distribution to members.
- b) To take enquiries and respond asap (either from existing knowledge or via consulting the rail authority involved).
- c) To be involved in decisions affecting the line.
- d) To bring forward ideas, proposals and suggestions for improving the infrastructure and trains.
- e) To complete surveys and gain evidence to support proposals.
- f) To facilitate the aims and objectives agreed with TFW or Network Rail.
- g) Lobby Parliamet, Welsh Government and Principal Councils as required.

#### 11. Special train services and the 1630 ex Shrewsbury-Cambrian Line

The meeting expressed concern over the loss of some 16.30 services ex Shrewsbury in favour of special trains. It was confirmed that this was not a permanent arrangement. The committee **AGREED** to object to any scheduled services being cancelled in favour of such services.







## 12.Date of next meeting

The date of the next joint meeting is Friday 9<sup>th</sup> January at 11am in Shrewsbury. This is a special meeting with TFW (a range of officers) and a separate note will go out on
