#### 1. Welcome by the chair

The meeting received a welcome from the Chair.

#### 2. Minutes of the last joint transport meetings

The meeting considered and approved the minutes of the last joint meeting held on 4<sup>th</sup> July 2025.

## 3. Actions since the last meeting

The following actions were noted from the last meeting:

- a) Arrangements for a Welsh Government representative have been made for attendance at the main Association meeting on 23<sup>rd</sup> January 2026.
- b) The secretary attended the rail 200 event in Aberystwyth.
- c) The secretary has met with Stena-line (Holyhead) and they are receptive for a meeting hosted by the Association with TRW and Avanti. This is to be arranged soon.
- d) The markings on the platform (5) at Shrewsbury for carriage identification on the Cambrian line are of little value. Unless all Cambrian bound trains depart from Platform 5 and unless the lettering is included on the electronic display boards the markings are of little or no effect. Further thought required.

## 4. James Nichols Transport for Wales

A presentation was given by James to the meeting (copy of this to be circulated following the meeting).

Points raised by members from the presentation were:

- a) Will the changes and improvements to Machynlleth Depot permit the maintenance of 3 car units? This would allow for expansion of usage which would be expected with the introduction of an hourly service. – ***all trains on the Cambrian Line are to be 2/4 units taken from the 21 new units with the ERTMS system fitted.***
- b) Interesting to see how many trains are short-formed on the Cambrian, i.e. 2 car units running far more often than 3 or 4. It is noticeable that passengers now often have to change at Shrewsbury from a 197 to a 158, which is vastly inconvenient to say the least. Is this likely to increase as the year wears on? – ***To be followed up and monitored.***

In relation to the anti-social behaviour in Flint, can we have increased visibility of transport police in the evenings as a number of local people have stated they feel uncomfortable waiting on the platform.

In addition, in relation to mental health, is there a possibility of putting signposts at railway platforms with contact number for the Samaritans or local mental health as there was a fatality at Shotton 24hrs ago. – ***Follow up 'samartan' signs.***

- c) SARPA hopes the idea to extend Platform 3 at Shrewsbury outwards to allow access to the Crewe line will be reconsidered. There is room for a crossover at the North End of Platform 3 as it stands which would achieve the same effect. Extending Platform 3 outwards will remove the separate through freight road and will be a lot of expenditure to achieve not very much. Last train Aber to Mach is 23:30. - ***comment noted.***
- d) Later trains – a later train from Aberystwyth and from Birmingham International to be considered. An earlier train on a Sunday would also be a good addition. – ***Secretary to follow up.***

- e) There is still a need for the meeting with Colin Lee regarding the hourly train service on the Cambrian Line and how this fits with the existing path being occupied by a Holyhead train. – **To be arranged.**
- f) The issue of overcrowding on many trains (as the norm) was noted.
- g) Can you please confirm that the call points will be on the platform and not in the car park?  
- **To be clarified.**
- h) Can TfW look at the front car park to see if the number of car parking places can be increased now not used by the Rail replacement service? – **This exercise was completed about 18 months ago.**
- i) Bilingual announcements on trains – TFW indicated that when the class 197 trains arrive on the Cambrian Line that all announcements would be bilingual. **Situation to be monitored.**

The meeting thanked James for his time and presentation.

## 5. Robert Gravelle Transport for Wales

A presentation was given by Robert and Zandra to the meeting (copy of this to be circulated following the meeting).

Points raised by members from the presentation were:

- a) Some of our group members have raised the issue that they have to time their journeys carefully as they have conditions where they need access to toilets. If a train is cancelled or delayed it can lead to real problems. Welshpool Station has a high footfall but very limited facilities. What are the plans for rolling out toilets to stations like Welshpool? – **There are no plans at present – to be kept on the agenda.**
- b) Are there any moves to improve Welshpool. Simple one was the painting of handrails red - suggested over 2 years ago and would help with dementia. Ramp is not to today's standard and very long and steep. Maybe lifts should come forward bearing in mind that Welshpool is one of the busiest stations along the line. – **TFW expressed surprise that the red railings painting had not been done. This is to be chased up. The ramp situation details to be passed to TFW.**
- c) Flint has a large proportion of disabled people due to the primary and secondary ALN schools. There is no changing place toilet in Flint. I have raised this previously with TfW, I would be grateful if this request could be looked at formally. – **TFW noted the situation.**
- d) How does Passenger Assist function when services are cancelled en masse - such as today? Many vulnerable people could be caught out..... - **No real answer on this one.**

- e) There is a huge issue at Welshpool station with the rail replacement service which now stops outside Tesco. Passengers have to go over a bridge and down to the platform to find out this information which is difficult for those with disability. We need an additional smart sign unit at the up ramp to Welshpool Station such as that that can be found in the middle of Porthmadog high Street giving both train and bus information. – **Further discussion between secretary and Gail Jones to be done.**
- f) In terms of inclusivity, where are we with getting bilingual announcements on Cambrian Line trains? - **TFW are looking at this. will seek update from station manager. Gail**
- g) Will it be a smart sign/information sign such as that in Porthmadog? – **To be followed up.**
- h) You mentioned level boarding. But the 197s will be higher than the existing 158s. Some platforms will be altered if they'd be non-compliant but most stations will see a significantly higher step from platform to train. How does this fit with equalities? Do more adjustments need to be made? – **More work to be done – to be monitored.**

## 6. Ross Rondel Transport for Wales (Buses)

A presentation was given by Ross to the meeting (copy of this to be circulated following the meeting).

Points raised by members from the presentation were:

- a) Big issue in any town or community is finding out where your bus goes from and to and when. In Llanfair we have put up 5 new bus stops with timetables in them. Result bus used Llanfair to Welshpool as more than doubled in a year. Just a thought. - **Noted.**
- b) What steps are being taken to improve integration not only within bus services but with rail as well? Over 25 years of Welsh Government and we still don't have an "All Wales Travel Card". - **Noted for future discussion.**
- c) Many of our resident's struggle with all timetables being in an app. The app is good, I use it myself, but I understand that not everyone can use it. – **App is fine but many do not have smart phones. Noted.**
- d) As I see bus transport it based on private companies are putting profit before decent bus services we need better regulation and better services. – **Standard of service delivery is important and all will be done to ensure good service. – To be monitored.**
- e) An integrated map of all bus services is very important (accepting that there are good maps of Traws Cymru services). E.g. London overground lines have substantially increased their patronage simply by including them on the well-known tube map. – **To be followed up.**

- f) A bus stop in Machynlleth in 2024! Admittedly things have improved since then (the sign is now upright, though not vertical!) but we need better than this. = **Noted.**
- g) We had a London Style network in 1986 called BWS GWYNEDD which worked well until for 10 years despite deregulation. The new approach should work but network planning needs to include connectivity which is now very poor in my area. Interchanges at Bangor, Caernarfon and LlanfairPG need development. - **Ross and Bob Saxby to make contact.**
- h) Can Town and Community Councillors be invited to these workshops, we have hyper local knowledge that would be beneficial. - **Yes they will be. There will be lots of in person and on line engagement opportunities.**

## 7. New trains in 2033

The subject of new trains for 2033 is to be carried over to the July meeting.

## 8. Surveys

Further surveys will take place in 2026.

## 9. Deganwy crossings

The secretary is to seek information on the current position.

## 10. Committee

### 10.1 Remit of the liaison committees

The meeting considered and agreed an outline remit for discussion with TFW as follows:

To receive updates and reports from rail operators and Network Rail.

To discuss topics and respond to consultations.

To make recommendations to the operators/Network Rail on rail matters.

To complete survey and other consultation works to support TFW and Network Rail.

To lobby both Parliament and the Welsh Government with regards to rail matters.

All discussions should be meaningful and allowing some influence in the subject.
